

Minutes of the Meeting of Kirmington & Croxton Parish Council, held on Tuesday, 5<sup>TH</sup> March, 2013, at Kirmington Bowls Club.

01.03.13- To note Apologies for Absence

Cllr Whincop, Cllr Clark, Cllr Bridges

02.03.13 - Declarations of Interest need to be remade and recorded in the minutes even if an interest has been declared in the register

Cllr Marsden declared a personal interest in any Airport or Aviation issues, as he works in the Aviation Industry. Cllr Marsden declared an interest on item 06.03.13, as he works in the Airport Industry and is a Member of the Airport Consultative Committee. Cllr Marsden declared an interest on item 09.03.13, regarding highway issues on the C137, as he owns a property accessed by this road.

Cllr Wells declared a personal interest in any item on the agenda in connection with North Lincolnshire Council as he is a Representative.

03.03.13- To confirm the minutes of the meeting held on 29<sup>TH</sup> January, 2013

These were confirmed as a true and accurate record, proposed by Cllr Page and seconded by Cllr Walton.

04.03.13 - Public Participation

05.03.13 - To receive the Chairmans Report - an update on decisions taken at previous meetings

All items are covered on the agenda.

06.03.13 - To receive an update from the Airport Consultative Committee meeting and Noise Monitoring

The next Airport Consultative Committee is to be held on 14.03.13.

Debbie Zost is the new Air Traffic Control Manager.

The Airport have replied to our invitation and advised they cannot attend the April meeting, but have requested dates for the future meetings.

Clerk to invite to June or July meeting.

The Airport also advised as far as they are aware the noise procedures in place are for aircraft not to fly over Kirmington, Searby, Grasby, Barnetby and Brocklesby House, these are local instructions, to Air

Traffic Control Officers and are not seen by Pilots. Cllr Marsden suggested that this should be published in the UK AIP Pilots document as well and asked Members present if he could raise this at the Airport Consultative Committee. All Members present agreed.

Cllr Marsden has received an invite to attend a meeting at the House of Commons on 23.04.13 on Sustainable Aviation (SA) Noise Road-Map Launch. It was agreed for the Clerk to write to MP Martin Vickers to see if he can attend this meeting and also to invite him to the Parish Council meeting that the Airport attend.

07.03.13 - To receive any updates from NATS and discuss any items to be raised at the next NATS meeting and any further Police Matters and any updates on Country & Wildlife Crime

Cllr Wells that there has been no reported incidents within Kirmington & Croxton.

All crime figures were low in other areas.

The next NATS meeting is on 06.06.13 at Barrow.

No updates on Wildlife Crime at present.

08.03.13 - To receive a report from Local Councillors updating the Parish Council on activities within North Lincolnshire Council and determine further action

Cllr Wells informed that the roundabout at the Airport is still on the agenda.

More funding may be available for speed signs.

09.03.13 - a . To consider any further Highways matters within the Parish for the Clerk to take up with North Lincolnshire Council

In response to an email received from the Brocklesby Estate the Councillors discussed the flashing speed signs due to be temporarily installed at Croxton. They all agreed it was a road safety issue and this would help reduce speeds. They would be initially installed as a 3 months trial.

Regarding the BT poles that go to Hendale Lodge, one has been replaced by BT. Brocklesby Estate have advised that Hendale Lodge will be renovated during 2013 and do not want the Parish Council to request the poles are taken down. All Councillors agreed not to ask BT. The poles have already been reported to North Lincolnshire Council.

Clerk read out reply from Bob Brooks at North Lincolnshire Council regarding the C137. This stated that there is little that can be done regarding the standing water problem. It also stated that the Area

Highway Inspector will monitor the condition of the patches and further action that is necessary will be taken.

There have been no updates on the C137 weight restriction.

b. To consider if signage regarding horses not using public footpaths within the villages should be installed.

A request has already gone into the Village newsletter requesting horses not to use the public footpaths. Email received from Brocklesby Estate advised they would prefer for these signs not to be installed. It was agreed by Members present not to request signage.

10.03.13 - To receive Planning decisions made by North Lincolnshire Council and consider any planning applications received where comments have to be submitted before the next meeting

12.03.13 - (a) - To discuss progress on the Playing Field grant and work to date

Cllr Walton has cut the grass recently for the first time this year.

The School has begun to use the Playing Field and Play Park again.

The Football Team is still using the facility and positive comments have been received.

Cllr Hannigan will arrange for posters and details of the event to be displayed in the Village Newsletter.

Cllr Marsden will speak to contacts to see if a balloon can be arranged.

Clerk to inform MP Martin Vickers of the Ceremony.

Clerk to chase up signage from Mondegreen.

Cllr Wells informed Cllr Hannigan if there are more than 6 stalls she

would need to apply for licensing.

Clerk read out reply from North Lincolnshire Council and Ernllca regarding the Parish Council concerns with control of dogs on the playing field. The information received suggested that responsibility lies with the dog owners and should an incident occur it would be the dog owner who would be responsible.

Cllr Walton declared a personal interest on item 12.03.13 regarding Dogs and Dog Control Orders.

All Members present agreed to monitor the situation and consider a Dog Control Order in the future should the need arise.

Clerk to arrange for new Library days and times to be displayed.
