Minutes of the meeting of Kirmington & Croxton Parish Council, held on Tuesday, 8th October, 2013, at Kirmington Bowls Club.

01.10.13- To note Apologies for Absence

02.10.13 - Declarations of Interest need to be remade and recorded in the minutes even if an interest has been declared in the register

Cllr Marsden declared a personal interest in any Airport or Aviation issues, as he works in the Aviation Industry. Cllr Marsden declared an interest on item 06.10.13, as he works in the Airport Industry and is a Member of the Airport Consultative Committee. Cllr Marsden declared an interest on item 09.10.13, regarding highway issues on the C137, as he owns a property accessed by this road.

Cllr Wells declared a personal interest in any item on the agenda in connection with North Lincolnshire Council as he is a Representative.

03.10.13- To confirm the minutes of the meeting held on 10th September, 2013

These were confirmed as a true and accurate record, proposed by Cllr Page and seconded by Cllr Walton.

04.10.13 - Public Participation

None

05.10.13 - To receive the Chairmans Report - an update on decisions taken at previous meetings

All items are covered on the agenda.

06.10.13 - To receive an update from the Airport Consultative Committee meeting and Noise Monitoring

The next ACC meeting will be held on 29th October, at the Airport. Cllr Marsden informed that Chris Wild has sent him an email advising the noise monitoring issues have been resolved and although no figures are available in time for the Parish Council meeting, he will let him know when the figures are available.

The Leader of North Lincolnshire Council, Liz Redfern has a meeting with Richard Lake and she will raise the subject of noise monitoring issues.
The Airport launches a new service to Copenhagen on 28th October.

07.10.13 - To receive any updates from NATS and discuss any items to be raised at the next NATS meeting and any further Police Matters and any updates on Country & Wildlife Crime

No Councillors' were able to attend the latest NATS meeting. Cllr Clark reported there were no incidents within Kirmington & Croxton.
Cllr Marsden advised he received a report of an incident in Kirmington of badger baiting, 3 males have been arrested with dogs and their vehicle has been seized.

08.10.13 - To receive a report from Local Councillors updating the Parish Council on activities within North Lincolnshire Council and determine further action

Cllr Wells reported that free car parking after 4pm will be introduced in Scunthorpe shortly for Xmas Shoppers.

09.10.13 (a) - To consider any further Highways matters within the Parish for the Clerk to take up with North Lincolnshire Council

Cllr Page is still waiting contact from North Lincolnshire Council, Clerk will chase.

There are no further updates on the C137 weight restriction. The experimental order was promised over a year ago. Clerk to write to North Lincolnshire Council and ask for the wires to be put out when the road is not partially shut and request update/inspection.

Cllr Gallimore advised the following update, via email - The new road signage has been completed in Croxton and they await the arrival of the illuminated flashing speed sign.

(b) To consider any quotations for 'squadron memorial' brown sign
Clerk has obtained a quotation from private sign company at cost of £146.85 x 4.

Cllr Marsden advise the best route for the signs is off the A18 Limber Road, off top of the High Street, as there are already 2 posts where the signs could be attached. 1 signs could be placed opposite the memorial pointing towards the memorial.

Permission is required from Highways. Clerk to write asking for permission, advising North Lincolnshire Council the Parish Council intend to position the signs, and to advise if do not hear from them within 30

days the signs will be erected.

The 'Kirmington' sign on Limber Road/Gypsy Hill needs to be replaced first as this is bent. Clerk to request from North Lincolnshire Council. The trees near to this sign also need cutting; this is one of the inspection matters that Cllr Page wants to point out to Wayne Hill on a site visit.

(c) To consider any quotations for Kirmington Village signs

Cllr Page has contacted a sign company in Caistor who would like to quote. Clerk to provide them with further details.

Cllr Page discussed sponsorship for the signs. Cllr Marsden will speak to the Airport regarding this at the next meeting. Cllr Page will also speak to a couple of contacts.

Clerk has chased up Somerscales Timber numerous times and has not been able to obtain a quote.

(d) To discuss Parish Salt Orders

All agreed to order 2 further bags of salt free of charge to be delivered to Stuart Lancaster's store.

10.10.13 (a) - To receive planning decisions made by North Lincolnshire Council and consider any planning applications received where comments have to be submitted before the next meeting

(b) - To discuss the email from South Killingholme Parish Council - re - Poplar Farm Planning

Cllr Wells declared a personal interest on this item.

All agreed to send a letter of support to planning once the application goes in.

11.10.13 - Any Updates on Singleton Birch AD Plant

Cllr Gallimore provided the following update via email - The construction of the new plant is on course for completion in March/April next year. Over half of the maize crop has been delivered with the balance due shortly; this will be stored over the winter months.

12.10.13 - Any Updates on Pimlico Farm

Cllr Marsden advised the site appears to be operational. There has been an increase in agricultural traffic on weekends on the C137.

13.10.13 -(a) - To discuss progress on the Playing Field and work to date

Cllr Walton reported that the broken bar on the lock gate has been

repaired. Joyce's will send Clerk the invoice.

Kissing Gate - awaiting quotation from Waterman's. Clerk to chase up so can be fitted as soon as possible.

Football team using field and have played 3 games so far. Still awaiting fixture list.

(b) - To consider the proposal of a pavilion on the Playing Field

14.10.13 - To discuss any further ideas for the layout of the Parish Council Website

The Website is still working well. Cllr Marsden will send Clerk photo to be displayed, but it has copyright on the photo, so Clerk will need to contact the person whose photo it is to ask for permission to use.

15.10.13 - To discuss ideas for Remembrance Day 2013

Clerk to order wreath and 14 crosses for collection from Ehrets on Monday 4th November so that they have them in plenty of time. Cllr Page will collect and drop the crosses at Cllr Hannigan's so that she can deliver them to the school.

Cllr Marsden confirmed the Standard and the Escort.

Cllr Marsden will be attending the Cenotaph in London for the 4th year running.

Rev'd Mary Vickers and the Bugler have both confirmed.

16.10.13 - Any updates regarding Broadband Speeds in the Parishes

Cllr Marsden and Cllr Wells both attended the launch of the North Lincolnshire Council Broadband scheme. The grant of £7.3million from ERDF to install broadband into rural areas will begin in April 2014 and Kirmington/Croxton will be in phase 2 of the project and this will start in June 2014. Openreach is the main provider who will provide Fibre Optic cable from the Exchange in Melton Ross to a new Green Cabinet in Kirmington. From there it will still run on copper cable to premises, the speed to the Cabinet is expected to be 24MB but then there will be some loss when it transfers to copper cable which will be dependent on the distance of the premises from the Cabinet. This project will be managed by North Lincolnshire Council.

17.10.13 - Correspondence

NLC - email re declaration of interest forms. All agreed that the forms should be reviewed as any changes to Councilors' circumstances occur, not

annually. Any forms required can be obtained from Clerk once requested.

Vacancy - Clerk to advise North Lincolnshire Council to arrange to advertise vacancy on Parish Council. However, Cllr Bridges has moved to Great Limber and has advised Cllr Page he wishes to remain on Kirmington & Croxton Parish Council. Clerk to contact him to confirm and will advertise vacancy once Cllr Bridge's intentions are known.

Smith of Derby - Clerk advised that in order to obtain the 15% discount on the servicing of the Church Clock the invoice needs paying in advance for the 3 years. Checked this was in order - All Councilors' present agreed to pay in advance.
