## 01.11.14- <u>To note Apologies for Absence</u> Cllr Hannigan

02.11.14 - Declarations of Interest need to be remade and recorded in the minutes even if an interest has been declared in the register Cllr Wells declared a personal interest in any item on the agenda in connection with North Lincolnshire Council, as he is a Representative. Cllr Marsden declared a personal interest in any Airport or Aviation issues, as he works in the Aviation Industry; he also declared an interest in Bristow Helicopters as he is undertaking some consultancy work. Cllr Marsden declared an interest on item 06.11.14, as he works in the Airport Industry and is a Member of the Airport Consultative Committee. Cllr Marsden declared an interest on item 09.11.14, regarding highway issues on the C137, as he owns a property accessed by this road. Cllr D'Souza declared a personal interest in any item on the agenda in connection with North Lincolnshire Council, as he is an Employee.

## 03.11.14- To confirm the minutes of the meetings held on $7^{th}$ October 2014

These were confirmed as a true and accurate record. Proposed by Cllr Bridges, seconded by Cllr Walton.

## 05.11.14 - <u>To receive the Chairmans Report - an update on decisions taken</u> <u>at previous meetings</u>

All items are covered on the agenda.

Cllr D'Souza attended the meeting at this point.

## 06.11.14 - <u>To receive an update from the Airport Consultative Committee</u> meeting and Noise Monitoring

The next meeting is scheduled for 26<sup>th</sup> November. Cllr Marsden should be able to attend.

Planning Permission has been granted for the permanent hotel.

British Aerospace is opening a 'training school' at the Airport which will bring more employment to the area.

The September noise monitoring figures are all acceptable within the Government guidelines.

# 07.11.14 (a) - <u>To receive any updates from NATS and discuss any items to be raised at the next NATS meeting and any further Police Matters and any updates on Country & Wildlife Crime</u>

No representatives were available to attend the latest meeting. There were no local issues reported within the minutes.

Wildlife Crime - Humberside and Lincolnshire Police are jointly resumed their patrols. 3 poachers were recently caught and had their 3 cars confiscated, at Hibaldstow, Worlaby and Isle of Axholme. The offenders were from the Yorkshire area. The AGN of this group is due to be held on 11.11.14 and Cllr Marsden will attend

### (b) - To consider a Representative for a Fire Warden

The Parish Council has no building, so have decided this is not required. However, the Bowls Club which is hired to hold the meetings does require signage and more than 1 fire exit. Clerk and Cllr Walton to speak to the Representative to arrange.

## 08.11.14 - <u>To receive a report from Local Councillors updating the Parish Council on activities within North Lincolnshire Council and determine further action</u>

Cllr Clark informed the Melton Ross bridge has recently been surveyed and is in a worse state the originally thought. There are 2 options - either repair at a cost of £2-3 million or install a new bridge at a cost of £6 million.

Police are now enforcing the weight limit, with 35 HGV's caught within a 2 hour period.

North Lincolnshire Council and MP Martin Vickers are applying for funding from Whitehall and better signage also.

## 09.11.14 - (a) To consider any further Highways matters within the Parish for the Clerk to take up with North Lincolnshire Council

Cllr Bridges expressed concerns of the tailbacks the Melton Ross bridge

diversion is causing. He stated the signage and diversion is not working. Cllr Gallimore advised she has informed Wayne Hill of this issue. Cllr D'Souza advised he has discussed the signage issue with Steve Harrison and new clearer signage should be in place soon.

IT WAS RESOLVED - Clerk to write to MP Martin Vickers and express Parish Council concerns, ask him what the Government is going to do about this bridge and the timescales involved. Cllr Page proposed 2 Parish Councillors arrange to meet MP Martin Vickers to discuss this further near the bridge to see the actual issues. Clerk to request.

Kirmington High Street - There is major parking problems at the school. The faded road markings need renewing. Clerk to request. The school would like double yellow lines opposite the school, but Cllr Wells informed the school would need to request these.

Cllr Wells will chase up Steve Harrison for the signage as promised for the High Street.

Clerk read out reply from Environmental Health Dept at North Lincolnshire Council regarding lighting issue on the C137 advised they are in discussions with the airport to resolve this issue. Cllr Marsden declared a personal interest as he is working with Bristow Helicopters.

### (b) - To discuss the weight limit - Kirmington High Street and the C137 North of Kirmington Crossroads to Croxton B1211

IT WAS RESOLVED - Clerk to request 7.5 tonne weight limit for Kirmington High Street, Eastend and on the road from Kirmington - Croxton and the back of Croxton Church.

### (c) -Any updates on Kirmington Village signs

These will be ordered during November, if no response from Wayne Hill at North Lincolnshire Council against them being erected.

Cllr Gallimore reported the season has ended and the traffic has reduced. She will obtain further update for the next meeting.

The RAF Lancaster will be in attendance and a member of the Dutch Royal family will also attend.

The 2 village schools are to set up communicating via a Skype link. The return visit is scheduled in September 2015 in conjunction with the 166 Squadron event which is organised by the 166 Squadron (Immingham) ATC.

It has been a good start so far, making progress.
