### 01.11.16- To note Apologies for Absence

### 02.11.16 - Declarations of Interest need to be remade and recorded in the minutes even if an interest has been declared in the register

Cllr Wells declared an interest on any item on the agenda in connection with North Lincolnshire Council, as he is a Representative.

Cllr Marsden declared an interest on item 09.11.16 regarding highway issues on the C137 as he owns a property accessed by this road.

Cllr Marsden declared an interest in item 06.11.16, as he works in the Aviation Industry and is a Member of the Airport Consultative Committee;  
Cllr Marsden also declared an interest in Bristow Helicopters as he is undertaking some consultancy work.

### 03.11.16- To confirm the minutes of the meetings held on 4<sup>th</sup> October 2016

These were confirmed as a true and accurate record. Proposed by Cllr Wells and seconded by Cllr Walton.

07.11.16 (a) - To receive any updates from NATS and discuss any items to be raised at the next NATS meeting and any further Police Matters and any updates on Country & Wildlife Crime

There was vandalism to Kirmington Church recently, which was reported to the Police. Cllr Marsden contacted PC Lee Fuller and Lewis Mundy regarding this latest incident. It was also reported on Countrywatch. There will be extra patrols within the village.

Cllr Hannigan will raise the vandalism incidents with PC Lee Fuller and arrange a leaflet drop. The Parish Council members were all in favour of this.

Wildlife Crime - Cllr Marsden advised badger baiting has started locally and hare coursing. He advised all Councillors to be vigilant as Deer Lamping season is starting.

08.11.16 - To receive a report from Local Councillors updating the Parish Council on activities within North Lincolnshire Council and determine further action

Cllr Hannigan advised the Ward Councillors recently met with the Cabinet Member for Highways. The C137 Croxton Road will be resurfaced and work done to improve the path. There will be slurry sealing at High Street, Limber Road, Main Street, Ransom Court.

The School Safety Zone should be in place by the end of the financial year.

09.11.16 - (a) To consider any further Highways matters within the Parish for the Clerk to take up with North Lincolnshire Council

Cllr Marsden advised the low flying helicopter signs have been installed on the C137, but with no plate on stating 'warning of sudden downdraft'.

West Lindsey Council have not replaced the missing Deer signs. Clerk to chase.

Cllr Gallimore asked on behalf of Singleton Birch why the B1211 into Croxton is not 40mph all along. Cllr Wells advised her to suggest Singleton Birch write to North Lincolnshire Council.

Cllr Gallimore expressed concerns over the gulley's in Croxton. Cllr Hannigan agreed to arrange meeting with Highways Department for inspection.

(b) - Any updates from Tim Allen regarding the Parish Paths Partnership

No updates received. Cllr D'Souza will obtain further info for the Parish Council to consider for the new financial year.

Sally, the Manager from the Marrowbone & Cleaver attended and advised the pub is currently being gutted and will open on 4<sup>th</sup> December, 2016. A planning application has been submitted to extend the opening hours by 1 hour.

Cllr Wells asked if the Defibrillator form could be completed by the Manager as soon as possible.

The Memorabilia is currently held by Cllr Green until required by the pub. Cllr Marsden discussed the 'Book of Remembrance' or the rolling photo frame idea to be held in the pub.

13.11.16 - To discuss progress on the Playing Field and work to date

Cllr Walton has recently purchased a mole trap.

The Football Club has held 2 friendly matches, but has not used the facility recently. Cllr Green will contact to see if still required.

The Lawnmower has been serviced and repaired and is ready for use.

Cllr Wells asked members whether any further play equipment is needed at the playing field.

Cllr Page replied he did not think that the Parish budget should be spent on any further equipment purchases. Cllr Walton stated that cutting around the play equipment already in place is extremely time consuming.

Cllr Wells asked members to look at the playing equipment at Barnetby & Elsham for ideas and to put the item on the agenda for discussion at the next meeting.

Cllr D'Souza advised the Parish Council will receive a grant. The amount is not known at present - it is dependent upon the number of votes. The votes are being counted at Brigg, Tesco's. Cllr D'Souza has spoken to Peter Lancaster regarding the improvements and he is happy for money to be spent in the garden. Cllr D'Souza suggested a Committee should be informed for ideas, etc.
