Minutes of the Parish Meeting of Kirmington & Croxton Parish Council, held on Tuesday 4th April, 2017, following the Annual Parish Meeting, at Kirmington Bowls Club.

02.04.17 - Declarations of Interest need to be remade and recorded in the minutes even if an interest has been declared in the register

Cllr Marsden declared an interest in item 06.04.17, as he works in the Aviation Industry and is a Member of the Airport Consultative Committee;

Cllr Marsden also declared an interest in Bristow Helicopters as he is undertaking some consultancy work.

Cllr Marsden declared an interest on item 09.04.17 regarding highway issues on the C137 as he owns a property accessed by this road.

Cllr Wells declared an interest on any item on the agenda in connection with North Lincolnshire Council, as he is a Representative.

Cllr Walton has cut the playing field grass recently. The mole man is trying to resolve the mole problem.

(b) - To discuss any further action required following the inspection of play equipment by Cllr Wells following NLC inspection

It was resolved for handyman to resolve the rust issues on the equipment and on the goal posts base. (Cllr D'Souza to provide Clerk with details of handyman).

Clerk to order 10 replacement caps from Sutcliffe Play for the dish in the park.

(c) - An update on the Tesco grant application

Clerk has submitted the application for funding towards a further piece of play equipment. A decision can take up to 6 months.

13.04.17 - To discuss any further ideas for the layout of the Parish Council Website

Website still receiving plenty of hits each month.

(b) - An update on the Grant application for Website funding

Clerk advised she has submitted an application and this may also be considered for backdating.

14.04.17 - (a) Any update on the Memorial Garden project

Following comments received from a few residents who responded, it appears the preferred option is to work with what is already on the site; looking at less maintenance options.

Some residents and Cllr D'Souza are presently maintaining the site.

Cllr Marsden advised Kirmington is now included on the Aviation Heritage Trail, along with the Marrowbone & Cleaver.

Cllr Marsden suggested the 166 Squadron Association located in Canada should be contacted once details of the project are known.

It was resolved that Cllr Marsden and Cllr D'Souza will work together for ideas for next month's Parish Council meeting.

Clerk advised she is awaiting quotes from Leake's for the improvement of the Church War Memorial. She provided Cllr D'Souza quotes from Barningham's. Once Leake's quotes are received she will contact NLC to see if a grant is available for the Church War Memorial.

(b) - To consider the terms of reference

It was resolved to accept the terms of reference.

15.04.17 - (a) Correspondence

Estuary TV - noted and Cllr Marsden agreed to be contact.

NLC - Invite for Workers Memorial Day - Read out and noted.

HSBC - Letter advising Brigg branch closing - Read out and noted.

Resignation Letter from Neville Page - Read out and noted - Cllr Marsden commented he was very sorry that he had resigned and it was resolved for Clerk to write letter of thanks to him for his years of work on the Parish Council. Also, to accept his offer to continue to fly the flags as required. - Clerk has advised NLC of vacancy and will await further instructions as to how to advertise the vacancy.

Audit - Clerk received Audit form and will complete during April.

(b) - Any comments to be submitted to North Lincolnshire Council for the Local Plan

It was resolved for Clerk to ask to be included: -

- Suggest a road to the South is required (Perhaps A15 or M11 extended northwards).
- Suggest the green area near Ransom Court/Limber Road is kept as

green land and not housing land.

(c) - To consider a donation towards the running costs of the village Newsletter

After consideration, it was resolved to donate £150 towards the costs.

(d) - To consider a donation towards the petrol costs of maintaining Kirmington graveyard

After consideration, it was resolved to donate £200 towards the costs.

16.04.17- Accounts

(a) To approve the March accounts - These were confirmed to be a true and accurate account. Proposed by Cllr Bridges and seconded by Cllr D'Souza.

17.04.17- Minor Items

Cllr Wells asked if he can tidy up the briars near the telephone box - this was agreed.

Cllr Marsden expressed concerns regarding the lack of footpath from the Airport to the village on the A18 to the Marrowbone & Cleaver and there is no speed limit on the A18 past the Airport up to the crossroad. Cllr Hannigan agreed to follow this up and see if this can be included as a Ward priority for the following financial year. It was resolved all members present were in favour.
